# ANTENNA RANGES

- $\sqrt{}$  Installed at entrances, exits, staff exits and possibly toilet facilities in your store.
- $\sqrt{}$  Transmits low frequency radio waves at the same frequency as the tags.
- $\checkmark$  Checkpoint NGL and EVOLVE iRange 360 RF Pulse listen systems are based on transceiver technology and therefore can operate as a single stand alone antenna.
- $\sqrt{}$  The technology is harmless and will not affect pace makers, hearing aids etc.
- $\sqrt{}$  When a tag enters the detection field an audible alarm is heard.
- $\sqrt{}$  The visible and audible alarm lasts for approx 5 seconds before automatically resetting.
- $\sqrt{}$  If a tag is left within the detection field the alarm will sound continuously until removed.
- $\checkmark$  All antenna systems require testing each day using a special 'Test tag'.
- $\sqrt{}$  The store manager is ultimately responsible for testing and reporting faults.
- $\sqrt{}$  It is essential that each and every alarm activation is responded to.
